REPORT TO THE COMMUNITY FROM THE EXECUTIVE DIRECTOR MONSIGNOR Kevin Sullivan

We are still in the afterglow of the visit from Pope Francis! The time he took to visit with the homeless and hungry served by Catholic Charities in Washington, DC and immigrants and refugees helped by Catholic Charities, NY punctuated the trip with a poignancy that is affirming, inspiring and scary. His presence concretized Catholic belief that service to the poor and vulnerable regardless of their religion and building the common good is essential to our faith. This is quite a challenge Pope Francis has left us.

PROVIDING HELP AND CREATING HOPE

This report highlights how Catholic Charities has been concretized providing help to those in need. Dedicated staff and volunteers, generous and important partnerships with government have enabled our federation of 90 agencies to provide an extensive array of services to alleviate the suffering of too many. Yet I'm not content and remain scared and troubled. Many people are being helped, but there is still too much pain and suffering. Too many people live – involuntarily - the cross of Jesus in their daily lives. We need to enhance our efforts to provide help and create hope for our neighbors in need.

CENTENNIAL 2017

Let me share how we are approaching our 2017 Centennial. Although numerous affiliated agencies go back to the 19th century, 1917 was the formal establishment of Catholic Charities as a federation of Catholic charitable agencies. A few years ago, Catholic Charities' Trustees set a direction – to launch a second century of service – with a strengthened and better funded Catholic Charities ready to meet the changing needs of the 21st century. While affirming our core services, the need to deepen these and meeting emerging challenges was also recognized. Catholic Charities Board insisted the Centennial not be a nostalgic look back, but a vibrant launching of a new century of service. Critical is the affirmation of Catholic Charities as a federation of independent affiliated agencies dedicated to helping New Yorkers of all religions. For the first time in its history, "A Guide to the Federation" was published, outlining the benefits and expectations of Catholic Charities affiliation. This guide acknowledged the commitment of women religious to these charitable endeavors. Without this sacrifice there would not be a Catholic Charities to speak of.

Let me provide a few of the highlights that give a hint of the legacy upon which we build to launch the next century of help and hope.

WELCOMING & INTEGRATING NEW AMERICANS

Pope Francis focused the world, for a brief, yet profound half hour this past September on a simple gym in East Harlem, NYC. He met and blessed 150 immigrants and refugees helped by more than 25 different Catholic Charities agencies, programs and partners. Among those present were: resettled refugees, families reunited, those gaining work authorization, day laborers and unaccompanied children. How we deal with the worldwide refugee crisis will be on the agenda in the upcoming years - made more complicated by ongoing terror and violence. This meeting put before the world a profound respect for the dignity of the human person made in God's image, from whatever country, whatever religion and in whatever circumstance. The meeting with Pope Francis was real, and not "a show," because of the skilled compassionate work done every day in protecting, nurturing, feeding, sheltering, strengthening, supporting and welcoming - far away from the spotlight.

Through Mercy Center in the South Bronx, Little Sisters of the Assumption Family Health Services in East Harlem, RSHM Life Center in Tarrytown and One to One Learning in Nyack, English, civics training and legal support are offered to individuals and families.

FEEDING & SHELTERING

Hunger – Last year two new generous corporate partners, Goya and Shoprite, enabled our Feeding our Neighbors campaign to collect more than 1 million meals to feed hungry New Yorkers.

Homeless – Housing and homelessness continue to plague us. Shelters grow, streets have too many people and more families struggle to pay rent. Shelters, affordable housing, eviction prevention, outreach to shelters and spiritual and emotional support to those in shelters and a decent meal are all part of the response that Catholic Charities makes to this sad situation. Pope Francis was clear in his visit to Catholic Charities in Washington, DC, no one should be without decent housing. But, too many are.

A number of our agencies address the needs of the hungry: Part of the Solution in The Bronx, Catholic Charities Community Services of Rockland County and our Ulster County Community Center provide meals and support on a daily basis. Those facing homelessness can turn to Catholic Charities affiliates such as Nazareth Housing on the Lower East Side of Manhattan and the Bronx, Newburgh Ministries in Orange County, the Dwelling Place in Midtown Manhattan and Fox House in East Harlem.

SUPPORTING THE CHALLENGED

Our major agencies that help the most vulnerable - those with developmental disabilities, abused and neglected children and adults with mental illness – face new complexities. Laudable attempts at efficiency and cost-cutting often threaten the most vulnerable as new systems unintentionally create obstacles for critical care. Our agencies have been nimble in adjusting, and vigilant in advocating for those served to make sure they are safe, protected and receive the services needed to live their lives in dignity.

These agencies include, Astor Services for Children and Families in Rhinebeck, Cardinal Hayes Home for Children in Millbrook, Mission of the Immaculate Virgin on Staten Island, St. Francis Residence in Manhattan, Kennedy Child Study Center in The Bronx and Harlem and St. Dominic's School in Rockland County.

PROTECTING, NURTURING AND STRENGTHENING FAMILIES AND CHILDREN

Catholic Charities agencies continue to focus on keeping families together and preventing the rupture caused by removing a child from the home – even temporarily. Even though there are many fewer children, we still provide safe and secure foster homes until a permanent solution can be found. After school and weekend programs help children succeed in school and have safe recreation. They make sure that high school students have every opportunity to finish school and go to college.

Many agencies strengthen families and protect and nurture children. Cardinal McCloskey Community Services, New York Foundling, Good Shepherd Services and Catholic Guardian Services are among those working to prevent children from being placed in foster care. Nurseries, after-school and sports programs run by agencies like Allianza Dominicana in Washington Heights, Abraham House, Casita Maria in The Bronx, Queen's Daughter Nursery in Yonkers and the Catholic Youth Organization provide safe and nurturing environments for our children to learn and grow.

THE BASICS: ACCOUNTABILITY, TRANSPARENCY, STEWARDSHIP – REAFFIRMED & VIGILANTLY GUARDED

Let me point out some basics that are not very fancy. I continue to be saddened by periodic reports of nonprofit mismanagement by those charged with helping the most vulnerable and entrusted with public and private funds.

I am pleased, but not complacent, that Catholic Charities has prioritized good governance and managerial accountability among our agencies – including and going further than independent audits. When mistakes are made our agencies respond quickly to correct them and add systems to ensure they do not happen again.



PROTECTING & NURTURING CHILDREN AND YOUTH (77,000 served, \$342 million in services):

Services include: day care, foster care, adoption, camping, sports & after school activities, community centers and preventative services

FEEDING THE HUNGRY AND SHELTERING THE HOMELESS (150,000 served, \$75 million in services):

Services include: emergency meals, emergency shelters, temporary & transitional residences, permanent affordable housing and preventing evictions.

STRENGTHENING FAMILIES & RESOLVING CRISIS

(134,000 served, \$105 million in services): Services include: information & referral, coordinating services, counseling, financial assistance, maternity services and job readiness & placement.

SUPPORTING THE PHYSICALLY & EMOTIONALLY CHALLENGED (13,000 served, \$250 million in services):

Services include: supportive housing for the mentally ill, counseling, residences for those with special needs & disabilities and early intervention & special education.

WELCOMING & INTEGRATING IMMIGRANTS & REFUGEES (38,000 served, \$18 million in services):

Services include: reuniting families, teaching English & civics, obtaining work authorization & finding jobs and preventing exploitation.

POINTS TO NOTE Administrative expenses are kept very low. On average Catholic Charities agencies of the Archdiocese of New York spends 88 cents of each dollar on program expenses. While many services are provided through government partnerships, substantial private philanthropy is necessary to sustain the range and quality of services offered by Catholic Charities agencies. The size of the individual segments of the chart represents a weighted average of the number of people served and the expenditures that hopefully reflects more accurately the proportion of services provided in each category. Some services, primarily residential, are very intensive requiring higher expenditures to serve a smaller number of individuals with special needs. Other categories, such as information and referral and emergency meals, serve many more people at a much lower cost per person. Because of Catholic Charities' comprehensive approach to assistance some individuals and families receive multiple services over a period of time. Some are served by more than one Catholic Charities agency. It is difficult to know the precise unduplicated number of those served. Our analysis indicates that Catholic Charities served more than 400,000 different individuals in 2014, approximately the same number served in the previous years.



Catholic Charities serves immigrants and refugees from more than one hundred different countries each year. Almost every Catholic Charities agency or program provides help and hope to newcomers. More than 150 newcomers – a cross-section of those assisted by 25 Catholic Charities programs – met with Pope Francis.


