FOR ASSISTANCE WITH DACA RENEWAL APPLICATIONS, PLEASE BRING:

Documents

- Two (2) copies of your Employment Authorization Document (front and back), even if expired



- Copy of your past submitted DACA applications (Form I-821D, Form I-765, Form I-765W)
- Copy of all past DACA Approval Letters
- TWO (2) Passport-style Photos
- Social Security Card
- List of addresses since previous DACA application was submitted
- If applicable, please bring:
 - ALL immigration documents: ex: visas, USCIS applications/petitions, approval notices, immigration court records, letters/notices from any immigration agency, immigration entry documents (if traveled outside US since given DACA)
 - ALL certificates of disposition (if arrested in past OR arrested since submitting your last application for DACA)

Fees

- Check/money order to “U.S. Department of Homeland Security” for application/work permit fees
 - **\$495 Application fee (\$410 for I-765 + \$85 biometrics)**

FOR ASSISTANCE WITH GREEN CARD RENEWAL APPLICATIONS, PLEASE BRING:

Documents

- Copy of your current Green Card (Front and back), even if expired
- Current and expired passport
- Copy of your Social Security Card
- Certificates of disposition, if applicable

Fees

- Check or money order to “U.S. Department of Homeland Security” for application fees
 - **\$540 Application fee (\$455 for I-90 + \$85 biometrics)**
- **OR**, if requesting a fee waiver
 - Copy of the most recent tax year returns
 - Proof of receipt of a public benefit (ie. Medicaid, SNAP, or Cash Assistance, NYCHA housing or Section 8)
 - Proof of financial hardship
