A charitable gift annuity (CGA), administered by Catholic Charities of the Archdiocese of New York, shows your support and appreciation for Catholic Charities of New York and its mission while receiving guaranteed income from those assets for yourself or a beneficiary that you name as long as you and/or the beneficiary lives. This is one way of providing help and creating hope for both non-Catholics and Catholics alike, while still supporting your needs and those of your family. A CGA is a contract between you and Catholic Charities of New York that guarantees a fixed amount of income for life. You can fund your annuity with cash or marketable securities.



HOW IT WORKS...

You receive an income tax deduction in the year that you establish the annuity for the gift portion of the contract. You receive a guaranteed periodic income that is not affected by the fluctuations of the marketplace. You receive a portion of your annuity income free of federal income taxes. You generally can prorate any capital gains taxes over the expected life of the annuity payments. You are free from concern about money management.




