





Serving **400,000 individuals** through **90+ agencies** on the ground locally at **300+ sites** in urban, suburban, and rural neighborhoods and communities throughout New York City and the Lower Hudson Valley.





Services include a vast network of soup kitchens, community food pantries, pop-up pantries and special delivery meals.

Services include day care, foster care, camping, sports and after-school activities, community centers and preventative services.

Services include reuniting families, teaching English and civics, obtaining work authorization and finding jobs, preventing exploitation, and supporting unaccompanied youth.

Services include information and referrals, keeping children with their parents, counseling, financial assistance, maternity services and job readiness and placement.

Services include emergency shelters, temporary and transitional residences, permanent affordable housing, and eviction prevention.

Services include supportive housing for the mentally ill, counseling, residences for those with special needs and disabilities, early intervention, special education, and prevention and treatment services.

Through the support of donors like you, Catholic Charities is able to continue programs devoted to feeding our neighbors, providing food assistance throughout New York City and beyond. Forty pantry sites across Catholic Charities supply nutritious food and support. Our homebound food program delivered 27,466 meals to the housebound last year.

Encore, which bills itself as "Broadway's Longest Running Act of Loving Concern," is a Catholic Charities agency founded in 1977. Encore donors come from New York's business and arts communities, concerned about meeting the needs of an often overlooked New York community, namely seniors who live in the Theatre District. They benefit from Encore lunches, meal deliveries as well as cultural and artistic community-building programs.

Encore lunch regulars come for the black bean and sweet potato chili, the menu item on one winter's day, offered at no cost for some 50 seniors in the basement of St. Malachy's Church in Manhattan's Theatre District. Nieves Taveras organizes activities at Encore.

"Food scarcity has become a big deal," Nieves Taveras says. "After the pandemic everything became so expensive." Manhattan rents continue to go up, creating a choice between paying for food and housing for many Baby Boomers aging in the city.

Because of Encore, seniors who might spend their days alone in their apartments are able to find both nutritious food and community. Encore is just one part of Catholic Charities' extensive effort to provide

food in New York City, funded in large part by donors who realize the importance that good nutrition has in turning around the lives of the most needy.

Children need space to be young, to be part of activities that nurture fair play and teamwork. Catholic Charities youth advocates and caseworkers help young people prosper, often against overwhelming odds. It's partners like you who help provide children with safe spaces to develop social skills and gain confidence.

Thanks to you, our network of services addresses the physical, emotional, and psychological needs of children and their families. Last year 53,387 youth participated in after-school programs, summer camps, and sports, 1,569 children were in day

care, 2,552 children were placed in safe foster care, 4,420 students took part in dropout prevention programs, and 13,337 enrolled in counseling services.

The Hoop Haven basketball program hosts boys and girls on evenings and weekends, sometimes with the help of players from the New York Liberty and the Brooklyn Nets. But it's more than just about learning basketball. In 2022, young people also were provided with work training, targeted assistance for troubled families, cultural programs and leadership workshops for youth that enhance pride and esteem.

Donor answers the call to help youth program

"What's most important to us is that the kids are learning," noted Phil Whalen. "Hoop Haven is not really about the basketball." Phil, a program benefactor, emphasizes that Hoop Haven provides a place of guidance for young people who struggle from disadvantaged backgrounds in northern Manhattan and The Bronx. It brings the youth together for both basketball and education.

A network of family and personal connections drew him to the program, operated by Alianza, a Catholic Charities youth division. Phil stepped in to provide financial backing, through the Mons Concepit Foundation, a family charity he leads with his sister, Mary.

Phil, principal of Key Real Estate, a Manhattan firm, has long held an interest in church and social causes. His Jesuit education, including St. Ignatius Loyola Parish School and Xavier High School, followed by Fordham University, nurtured in him the Jesuit ideal of service to others, a legacy carried out by his commitment to the children of Team Catholic Charities.

Catholic Charities welcomes and assists immigrants and refugees from every continent through a comprehensive array of legal and social services. These include reuniting families, teaching English and civics, applying for citizenship, obtaining work authorization, finding jobs, preventing exploitation, legal orientation and representation, and supporting unaccompanied youth.

Through your generous support Catholic Charities supports refugees so they can prosper and thrive in their new home. Among them are Tyhran Khosrovian and Olena Holeha, a young couple, both trained dentists, who joined hundreds of thousands of their fellow Ukrainians displaced by war.

"It's all unreal to us. Sometimes it's unbelievable that we are here, really," says Olena.

Caseworkers helped Olena and her fiancé Tyhran settle in Sheepshead Bay, Brooklyn. Escaping the bombing in Mariupol, Ukraine, Olena and Tyhran came to Catholic Charities New York with very little. They were enrolled in ESL classes and were provided emergency assistance, including basic furniture. Now settled into their new American home they are trying to find their way. "We really want to apply our knowledge here, too," Tyhran said. "We would like to enroll, study, get a license, and just show what we can do."

Because our supporters share our belief that everyone deserves to be treated with dignity and respect, in the past year we were able to assist 4,187 people with free legal immigration services in 36 languages.

Catholic Charities reunited 4,874 separated families and assisted 4,533 frightened unaccompanied minors. We answered 105,000 immigration **helpline calls** and staffed legal clinics from New York City to the Lower Hudson Valley.

Through the generosity of our supporters, Catholic Charities will be able to continue to assist refugees like Olena and Tyhran so that they can prosper in their new home.

Your commitment to Catholic Charities family programing allows us to provide hope to New York families. Under immense pressure, a growing number of parents must now cope with rising rents, food inflation, and the growing poverty gap.

In 2022, Ny'Lasia Gilmore Martin came to the Catholic Charities agency, Big and Littles, NYC for help with her four children Jamir, Kadir, Nyir, and Nylasia. Bearing the weight of parenting alone with long overnight retail shifts, Ny'Lasia found it hard to provide the basics to her children. Alongside caseworkers and because of your generous support, new beds and a crib were purchased, replacing mattresses on the floor.

Together we connected 92,767 people like Ny'Lasia to life-changing resources, answered 24,000 helpline calls, provided emergency assistance to 7,250, and provided job training to 6,511 people. Families continue to be stabilized because of your support of our mission. You helped to create hope for thousands of families in need.

There's nothing more scary or stressful than not having a place to live. Our dedication to helping the homeless extends to a variety of services that offer safety and shelter to those who need it most. Thanks to the help of our donors, we assisted 4,677 households at risk of eviction with rental assistance.

Pregnant, Tameca Gathers fled a troubled relationship several years ago, taking herself and her two children to a shelter.

"I sat there and cried with my kids," she said, "because I didn't want to start all over again." She prayed that God would help her find a way out.

Tameca was approved for a furnished two-bedroom apartment, in a Bronx building operated by the Association of New York Catholic Homes, an agency of Catholic Charities New York. Through the help of Catholic Charities, Tameca and her family were able to escape the city's shelter system.

Helping people navigate New York's housing system and working to place people in need in affordable housing is what we do. Last year, thanks to the support of donors like you, we helped 12,160 families to avoid homelessness. Another 14,505 people were provided with overnight **emergency shelter.** Your generous support transforms lives everyday.

Part of Catholic Charities New York's core mission is to assist people with physical, emotional, developmental, behavioral, and substance abuse challenges. These disabilities come in many forms — both visible and invisible. We offer a network of specialized support services to help and our programs are designed to provide quality care and social inclusion.

Last year alone, 1,003 people were cared for in residences for special needs, 1,468 preschoolers obtained early intervention/special education, and 35,610 people were treated for substance abuse.

Supporters like you help clients facing difficulties every day. Edward Regalado's journey began in 2020 when he was diagnosed with amyotrophic lateral sclerosis (ALS). With his health worsening, this husband and father of three was no longer able to provide for his family.

Edward's family sought help from Catholic Charities. Because of supporters like you, Edward and his wife are receiving help with his special dietary needs, have enrolled in the SNAP program, are receiving emergency rental assistance, and have been provided with mobility aids Edward needs to lead his best life, as independently as possible.





TRUSTEE PROFILE: **SUSAN C. SALICE**

Susan C. Salice is the president of the Salice Family Foundation. She has served as a Board member at Catholic Charities for over 10 years where she has served as co-chair of the Development Committee and served on the Marketing and Centennial Committees.

Susan is one of six children, raised in Upstate New York, near Lake George. Her parents' strong Catholic faith was the foundation of her upbringing. She attended St. Mary's Academy in Glens Fall, NY,

and, with scholarship dollars was then able to attend Fordham University where she met her husband, Tom. For the next two decades, Susan worked as an executive in the retirement services industry, before settling with her husband in Westchester County to raise their three daughters. Susan became engaged in and led many volunteer activities, which motivated her to formalize her study with a master's degree in Philanthropy and Fundraising from New York University.

With enthusiasm, Susan initiated a St. Nicholas shopping day in Westchester County, aka SNOW, which was very successful at engaging volunteers in Westchester in the mission of Catholic Charities, while providing items of necessity to families in need during the Christmas holiday season! Susan also introduced Team Catholic Charities NY, an annual team of runners participating as a charity partner in the NYC Marathon. Now in its 10th year, Team Catholic Charities has welcomed many new friends as runners and donors and has raised important funds to support the work of Catholic Charities.

Susan has worked in the philanthropy sector for over 30 years, including as executive director for a local Westchester nonprofit, a pioneer of a women's giving circle, and leader of an annual backpack distribution serving over 2,000 youth in need and an underwear initiative for shelter residents. Susan has served as a board member at several non-profit institutions, which currently include Fordham University and Greenwich Hospital.

Susan devotes her time and resources to the causes that are important to her and her family. The work of Catholic Charities is one of those.
